American Jewish World Service (AJWS) is the leading Jewish organization working to promote human rights and end poverty in Africa, Asia, Latin America and the Caribbean.

WHAT WE DO

AJWS uses its **grants-multiplier model** to make demonstrable human rights progress. Through this one-of-a-kind strategy, our donors are helping AJWS make change in three unique ways: We **fund** more than 500 social change organizations around the globe; we **accompany** our grantees through local staff who share knowledge and bring grantees together, enriching and emboldening social movements; and we **advocate** in Washington, D.C., and internationally to educate legislators and shift laws and policies that promote human rights and strengthen grassroots efforts to combat poverty, oppression and injustice worldwide.

OUR ISSUES

Sexual Health and Rights

We support 180 organizations empowering women, girls and LGBTQI+ people to stop violence and discrimination and live with dignity, safety and health.

Civil and Political Rights

We support 162 activist organizations advancing civil and political rights around the globe—promoting justice under the law for all and the right to be heard, vote and participate in political life.

Land, Water and Climate Justice

We support 167 grassroots groups fighting the climate crisis and protecting the land, water and natural resources that rural and Indigenous people depend on for survival.

Disaster and Humanitarian Response

In the wake of earthquakes, hurricanes, droughts, epidemics and other crises, we support grassroots organizations to provide relief, save lives and build resilience for the future.

WHY WE PROMOTE HUMAN RIGHTS

AJWS strives to overcome the root causes of oppression and inequality by supporting grassroots organizations and social movements for justice. We fund grantees to fight for people’s rights—to live without violence, to influence the laws and norms that govern their societies and to freely express their full identities.

Beyond grantmaking, we serve as thought partners to our grantees and help them improve their organizations and programs. We also support our grantees to form and participate in social movements—gaining the power to transform society on a much larger scale.

Meanwhile, AJWS staff in Washington, D.C., and a base of rabbis, cantors, Jewish leaders and supporters advocate to Congress and the executive agencies to protect and promote the rights of marginalized people everywhere.
